The 2022-2023 identified SPSA goals align with the identified current district LCAP goals. The SPSA and LCAP goals are mapped to the 8 state priority areas. The district LCAP goals are:

Goal 1: All graduates are socially just and ready for college and careers (1,2, 4, 7,8)

Goal 2: English Learners will become proficient in English while engaging in a rigorous, culturally and linguistically responsive standards-aligned core curriculum (1, 2, 4, 7, 8)

Goal 3: All students and families engage in safe, well-maintained schools that are culturally responsive and conducive to 21st century learning(1,3, 5, 6)

Malibu Middle School does not receive Title 1 funds.

### **Surveys**

This section provides a description of surveys (i.e., Student, Parent, Teacher) used during the school-year, and a summary of results from the survey(s).

In Spring 2021, a school culture and climate survey was administered to students, staff and parents (n=235). 84% of students either strongly agreed (38%) or agreed (46%) that they like Malibu Middle School. 5% disagree or strongly disagree with the remaining students being neutral. 67% of students report that they learn a lot in their classes while only 37% of students feel that their schoolwork relates to the outside world. 72% of students report that the school develops their critical thinking skills and 71% listening skills. Only 43% of students report that the school develops skills for managing emotions. 90% of students feel that their teachers want them to succeed and 83% reported that their teachers provide extra support. 85% of students said, with race and ethnicity in mind, they feel welcome at school and 84% said they feel included. 15% of students reports experiencing racism/discrimination at school. Of the parents who responded, 75% agree or strongly agree that they like Malibu Middle School. 85% of parents said they feel Malibu Middle School encourages their child to do their best at school. 75% of parents feel that staff members engage with parents and respond to questions/concerns. 50% of parents feel that staff provide resources to help their kids, communicate with them regarding their child's behavior and academics. 83% of parents feel the school encourages them to volunteer and 67% of parents feel their input is taken into consideration to improve instruction. No staff data was reported.

Previously, a student engagement survey was administered during the 2019-2020 school year to grade 6 (109 students participated) and grade 8 (90 students participated). 62% of students reported that generally they like school almost always, always, or often. This is up from 55% in 2018-2019 and 57% in 2017-2018. 87% of students agree or strongly agree that they try their best in school. Overall engagement score which factors in all engagement questions for 2019-2020 reported 80%. 78% of students feel accepted in the school. Highest ranking indicators are I am nice to my teachers at 99% and I am nice to my classmates at 98%. The lowest ranking indicators were I share my ideas to make this school better at 68% and I encourage other students to get involved in school and activities at 61%.

A school climate survey was administered during the 2018-2019 school year by staff soliciting feedback on academic support, student support, school leadership, faculty relations and supports, family involvement, safety and behaviors. 100% of staff report there is an adult kids can go to for help with a personal item. 97% report the same for a school item. 93% feel students are challenged by their schoolwork. 93% feel families are informed and encouraged to attend school sponsored activities. However, only 40% are aware of safety and security procedures, 34% say the school offers a variety of activities and courses, 33% say administrators are available if they have a concern, 33% report administrators communicate the schools mission and vision, and 33% say administrators provide useful feedback about their work. No similar survey was administered in 2019-2020.

The CA Healthy Kids Survey was not administered during the 2020-2021 school year due to school closures. It was given to students in grades 7 and to parents in grade 6-8 in 2019-2020. However, sites have only received information from the parent and staff survey and not the student survey as of this time.

Parents (sample size 71) results showed:

With regards to parental involvement- 79% of parents agreed or strongly agreed that the school encourages me to be an active partner with the school in educating their child; 83% agree or strongly agree that the school staff treats parents with respect; 82% agree or strongly agree that school staff are helpful to parents; and 97% of parents have attended a general school meeting; 83% agree or strongly agree that the school keeps them well informed about school activities.

With regards to student learning environment- 82% of parents agree or strongly agree that the school has adults who really care about students; 83% of parents agree or strongly agree that school is a safe place for students

Staff (sample size 19) results showed:

With regards to student learning environment- 100% of staff agree or strongly agree that the school is a supportive and inviting place for students to learn; 86% agree or strongly agree that the school promotes academic success for all students; 93% of staff agree or strongly agree that the school sets high standards for academic performance for all students

The summary from the 2018-2019 student administration of key indicators in Grade 7 shows 67% agree/strongly agree in regards to school connectedness, 73% in regards to academic motivation, 3% chronically truant,67% caring adult relationships, 75% high expectations, 29% meaningful participation, 29% facilities upkeep, and 48% parental involvement. 66% perceive school as safe, 23% experienced harassment or bullying, 39% had mean rumors or lies spread, 10% been afraid to be beaten up, 16% been in physical fight an 4% seen weapon on campus. 3% report current alcohol use in last 30 days, 0% marijuana use, 0% binge drinking in last 30 days. 0% report being drunk or high at school 7 or more times ever and 0% at least once. 0% report cigarette use in last 30 days, and 0% report e-cigarette use. 33% have experience chronic sadness/hopelessness and 10% considered suicide.

The OLWEUS student perception survey on school climate and bullying behaviors was not administered during the 2018-2019, 2019-2020 or 2020-2021 school year due to school closures. However, results from the 2017-2018 and the 2016-2017 school year were reviewed. The survey summary data includes students in grades 6-12 with 42.2% of students reporting liking school or liking school very much in February 2018. 9% of students reported having 1 or fewer friends. 73% of students report never having been bullied with an additional 17.5% stating once or twice. The most prevalent (31.2%) place where bullying occurs is in class with teacher present. 88% of students say they have never bullied others with an additional 8.2% saying once or twice.

An English Learner Parent Survey was administered during the 2018-2019 school year. 83% of EL parents knew where to find info about school beliefs, policies, procedures for ELS, but only 71% understood EL core beliefs. 92% know how child identified, 69% reported being familiar with reclassification process. Only 65% agreed or strongly agreed they understand what their child needs to do to become fluent English proficient. No similar survey was administered in 2019-2020.

### **Classroom Observations**

This section provides a description of types and frequency of classroom observations conducted during the school-year and a summary of findings.

Teachers are observed by administrators during the formal observation process. Additional informal observations are conducted by administrators throughout the year. SLT funds can be used for sub days to allow for peer observation and collaboration. Observations show that teachers value instructional time and use effective instructional strategies. Give our new buildings and new flexible furniture, students are often times seen working in groups or partners. Classroom observations show that teachers build positive relationships with their students and students feel comfortable and welcome in the classroom. Students are encouraged to use academic language in their classrooms and often engage in classroom discussions. More student talk and less teacher talk is still an area that we need to build on.

### Standards, Assessment, and Accountability

Use of state and local assessments to modify instruction and improve student achievement (ESEA)

CAASPP was not administered in 2019-2020 or 2020-2021 due to school closures.

2018-2019 CAASPP Data:

58% of all students met/exceeded standard in mathematics 42% did not meet or nearly met standard in mathematics.

72% of all students met or exceed standard in English Language Arts 28% did not meet or nearly met standard in ELA

Interim assessments in ELA and Math were administered. Fastbridge and STAR Renaissance were also administered. Student data was provided to staff and reviewed in departments. Teachers were subbed out to collectively score the IAB writing sections.

Use of data to monitor student progress on curriculum-embedded assessments and modify instruction (EPC)

Malibu Middle School created an SLT (separate from the high school for the first time) is 2019-2020. Using data and survey results, our focus was determined to be:

Using data to drive instruction and decisions, we will address the needs of all students by supporting the development of effective communication and reasoning skills so students will be able to use academic language to justify their claims in completing cross curricular PBL/Deep Learning projects.

The goal of the SLT is to:

- 1. Analyze data to identify student needs (schoolwide)
- 2. Determine a focus for the school based on those needs (what we need to implement to help students)
- 3. Determine supports needed for staff in the focus area so they can meet students' needs
- 4. Collect evidence of learning to inform our actions

For the 2019-2020 school year, the SLT team determined that the focus would shift to all Distance Learning and integrating technology across all classrooms.

For the 2020-2021 school year, the SLT determined that the focus would remain on providing a rigorous Distance Learning program.

For 2021-2022, the SLT determined that while continuing to work on effective communication and PBL, staff would also focus on students mental health, well being, and inclusiveness at school.

State assessment data has continued to show that while MMS performs well overall in CAASPP, there is still a need to address the gap between ELA and math performance, as well as an achievement gap among our subgroups (Socioeconomically disadvantaged, special education, and Hispanic/Latino).

### **Staffing and Professional Development**

Status of meeting requirements for highly qualified staff (ESEA)

All staff at Malibu Middle School are ESEA highly qualified. We have no teachers working out of assignment. SMMUSD HR Dept audit verifies MMS teachers meet the highly qualified requirements.

Sufficiency of credentialed teachers and teacher professional development (e.g., access to instructional materials training on SBE-adopted instructional materials) (EPC)

All teachers are credentialed in the area of their instruction according to analysis of the master schedule. The SLT team met to plan the PD calendar and continues to meet monthly to make changes as needed based on staff feedback and data. All students have access to materials (based on the Williams compliance board resolution from the beginning of the year). Teachers also have supplemental materials, technology, resources, and professional growth materials.

Alignment of staff development to content standards, assessed student performance, and professional needs (ESEA) Staff development during the 2021-2022 school year is focused on alignment with the CA state standards, our SLT Plan and district initiatives that support student achievement. Staff development and goals of PLC time are focused on appropriate instructional strategies and school wide actions identified through an ongoing process of reviewing a variety of lead and lag data. The SLT teams meet quarterly and throughout the school year to monitor the effectiveness of staff development and revise as needed.

Ongoing instructional assistance and support for teachers (e.g., use of content experts and instructional coaches) (EPC) Our PD is planned and delivered by our SLT with the support and guidance of our Instructional Coach, teacher leaders, and district staff as well. In addition to site level work, there are district provided opportunities for departments to work with content experts. The district also facilitates ongoing PD cohorts.

Teacher collaboration by grade level (kindergarten through grade eight [K–8]) and department (grades nine through twelve) (EPC)

Teachers collaborate on campus through a core grade level PLC structure. These meetings are scheduled on Fridays, where the student release time is 1:35 pm, allowing for common planning and meeting from 7:35-8:20 and 1:40 pm-2:30 pm weekly. The PD calendar rotation is developed collaboratively with the SLT and is reviewed and adjusted throughout the year based on need.

### **Teaching and Learning**

Alignment of curriculum, instruction, and materials to content and performance standards (ESEA)

Curriculum is aligned to the California content standards. We use CDE adopted textbooks and supplemental materials to meet the needs of all learners.

Adherence to recommended instructional minutes for reading/language arts and mathematics (K–8) (EPC)

The middle school range exceed the minimum number of instructional minutes required by the State of California. For the 2021-2022 school year, a new bell schedule with a later start time was voted on by all staff and implemented.

Lesson pacing schedule (K–8) and master schedule flexibility for sufficient numbers of intervention courses (EPC)
All students at MMS have access to a support class and can travel between classes depending on the type (subject

All students at MMS have access to a support class and can travel between classes depending on the type (subject area) of support needed. We have also built in an academic tutorial class that students can be recommended for in place of an elective. The SST looks at these recommendations to determine placement of kids in this class.

Availability of standards-based instructional materials appropriate to all student groups (ESEA)

All grades and subject materials are standards-based and MMS is William's compliant.

Use of SBE-adopted and standards-aligned instructional materials, including intervention materials, and for high school students, access to standards-aligned core courses (EPC)

All courses at MMS are standards-aligned from 6-8, including materials.

### **Opportunity and Equal Educational Access**

Services provided by the regular program that enable underperforming students to meet standards (ESEA)

MMS is an inclusive program and provides multiple sections of support for students who are underperforming. This includes the block schedule support, as well as regularly scheduled SAI classes. All English Learners receive integrated ELD support across their core classes. A supplemental ELD elective is offered in our master schedule. We also offer an academic intervention class in our master schedule.

Evidence-based educational practices to raise student achievement

MMS teachers utilize a number of research-based practices which are shared through our use of PLCs to meet the needs of all students and close the achievement gaps. Professional development is aligned with SMMUSD initiatives, which are based on current educational research and in consultation with professional experts outside of SMMUSD.

### **Parental Engagement**

Resources available from family, school, district, and community to assist under-achieving students (ESEA)

The primary channels for parental and community involvement are PTSA, SSC, POMS, Arts Angels, and a newly formed Latin X parent group.

MMS benefits from a number of community partnerships including Malibu Boys and Girls Club, City of Malibu, Malibu Optimist Club, Malibu Rotary Club, Malibu Womens Club, LASD, NAMI, Wellness Center, and others.

Currently, MMS students have tutoring after school available in the library 4 times a week after school. The Malibu Boys and Girls Club also offers tutoring 5 days a week. The SEA program also matches our students with tutors from Pepperdine. In addition, students have access to the Wellness Center.

Involvement of parents, community representatives, classroom teachers, other school personnel, and students in secondary schools, in the planning, implementation, and evaluation of ConApp programs (5 California Code of Regulations 3932)

Members of the SSC participate in the decision making process for the use of Formula and Stretch Grant funding for professional development as part of the SPSA process. We also present and seek feedback from our SLT and department chairs.

The primary channels for parental and community involvement are PTSA, SSC, POMS, Arts Angels, and a newly formed Latin X parent group.

### **Funding**

### **ANALYSIS**

Our teams are working well together to collectively address academic needs based on data. We've added an academic intervention class period that students can take as an elective. Students are identified by teachers, SST, and or counselor.

DISTANCE LEARNING: Distance learning/crisis instruction included a combination of live and independent learning experiences, synchronous and asynchronous lessons and learning activities delivered by credentialed teachers and supported by classified staff to ensure appropriate and effective instruction and connection to students. Teachers provided 240 minutes of daily live instructional time, except for the compressed day, using a modified 9:00am-2:00pm schedule. Students' experience with live instruction varied and consisted of a combination of whole group, small group, one-on-one live instruction and independent work for students. To ensure a guaranteed and viable curriculum was implemented district-wide, teachers met as district/site department teams and core grade levels to identify the essential standards and critical areas in SMMUSD's curriculum guides. To monitor student learning, teachers used assessments at the start of the year to determine student performance levels and identify areas of need particularly in the areas of English language arts and mathematics. Staff needs and department/schoolwide strategies shifted due to distance learning. Needs included tech integration, collaborative task design, building community virtually, assessment virtually, what data can we use to monitor student progress remotely, and enrichment activities. These strategies were fully implemented and as a result the Malibu High community navigated the Covid school closures better than most schools. Students and parents reported very positively having a single learning platform in Google Classroom. Grading practices were revised districtwide which included a minimum F, a 5 day grace period, and increased flexibility.

None, the main shift in expenditures was a result of being virtual until April, 2022. Implementation of strategies similarly was impacted as we were virtual, then focused on developing a distance learning plus enrichment model, followed by a return to in-person simultaneous teaching model.

Student need shifted and required adjustments between keeping students engaged, ensuring student work was their own, addressing lack of socialization, facilitating in-person activities to the greatest extent allowed within the protocols.

Goal will remain the same since there was no CAASPP data from 19-20 0r 20-21. Since we have no CAASPP data, we will look at district interims and STAR data.

DISTANCE LEARNING: Teachers and students hope distance learning, especially simultaneous teaching, is a thing of the past. For the 21-22 school year, students and families had to select between a full, 5 day a week return or participation in Independent Study, aligned with new state legislation.

CORE PLC TEAMS: There is a desire to continue to develop the collaboration amongst core/grade level teachers. Prior to covid, core grade level teams were planning cross curricular projects. The teams want to continue to build on these projects.

We continue to take both a targeted and schoolwide approach to our support of English Learners. Supplemental ELD class provided and taught by a middle school core teacher. ELAC was in it's first year and although we only had 3 members, we were able to support those families and they were able to provide input on our SPSA.

DISTANCE LEARNING: Teachers provided differentiation for EL students through the use of small groups delivered during their 80-minute instructional period and during identified support time. Teachers utilized small group instruction and any additional time built into the day to target

Teachers used integrated ELD strategies to support EL learners including visuals, videos, templates, sentence frames, vocab banks, and front-loading as much as possible. It was a definite challenge to differentiate for the varying needs. During distance learning, there was standardized/supportive communication when students weren't engaging to students and parents. After school tutoring with Math and English teachers continued virtually. We were able to work through all technology issues including hardware, hotspots, and connectivity issues. Paraeducator support during distance learning was incredible. Our team was reliable and given the format and break out rooms structure, the extra adult support benefited all students. An in-person SPED/504 Hub opened in January to better support students with formal plans.

ENGLISH LEARNER: The EL Lead Position monitored student progress per district protocols. Our EL Lead continued to check in and provide info to teachers of EL students, monitor EL student performance, and hold language access team meetings during distance learning. A supplemental ELD elective class continued in the master schedule. ELPAC Summative was administered in the spring in person. Students largely performed well, and some are taking AP English with the necessary integrated supports in coursework. We did not continue trainings on ELA/ELD Framework and responsibility to provide designated and integrated ELD.

SST: SST continued to meet during distance learning with parents and teachers identifying students struggling with distance learning. All available supports were offered, provided, and monitored but with no in-person options available were limited.

INTERVENTION: During distance learning, support period shifted to mandated schoolwide office hours. Unfortunately, students did not use virtual office hours in all subject matters or to a large degree. Our team is working this year to make better use of support time for all students. Paper was added as a 24/7 online tutoring resource.

Currently there are no major differences between the intended implementation and budgeted expenditures. Since many of the strategies that are used to support our EL students are schoolwide approaches, many of the expenditures are listed under goal #1.

Therefore we need to advocate for additional supports beyond the supplemental ELD elective, textbooks and materials in Spanish. In speaking with English Learner students and parents, they request exploring hiring a bilingual instructional assistant and/or contracting with agency to translate work and materials beyond the textbook.

SST: Ongoing need to identify through data and assessment students who may need intervention to meet their needs through a revised and better understood SST process (Monitoring/Referral).

INTERVENTION: . As we have come back to in person learning, there is a certainly behavioral (socialization, routine of school) need and social/emotional need (stress/anxiety/depression) that is presenting.

## **ANALYSIS**

Describe the overall implementation of the strategies/activities and the overall effectiveness of the strategies/activities to achieve the articulated goal.

Our strategies were effective as we saw in the results of the survey. We had a large percentage of parents take the survey as well. We hope to build on this momentum but know the challenges in place with distance learning this year.

DISTANCE LEARNING: Students received social-emotional support virtually through the Wellness Center. Programming including the Kind Campaign assembly, NAMI workshops, and asynchronous Social Emotional and well-being lessons were offered with varying degrees of success. Distance learning provided structures for students to stay connected, engage in new learning, and reduce loss of learning and access valuable resources but many students expressed missing the

socialization with friends and the extra and co-curricular programs that normally make school worth attending. Teachers posted a Week-at-a-Glance Summary of all assignments for the week on Google Classroom which parents received which was very effective in maintaining positive school-parent connections. Teachers reported that tech tools and tech integration (ie: Flipgrid, kahoot, nearpod, screencasify, newsELA, desmos, padlet, zoom) allowed for immediate feedback, increased student participation and engagement, helped with discrete assessment.

CLIMATE/INCLUSIVE PRACTICES/IDENTITY INCLUDING RACE: Both remotely and upon return we were able to maintain our inclusive school culture. Teachers attempted tier 1 community building activities in all courses. Through the Monday Message, social media, targeted messages, the administration team worked on messaging, especially on our shared values and interests during a time of turmoil. Positive relationships, staff to student and student to student, continued to be a strength. We were largely unable to facilitate activities to promote interaction across social groups. Some of the Anti-racism and Social Justice actions able to be conducted were: Curriculum: US History (ACES)(Facing History), Curriculum: English Department audit of required readings. Additionally, the principal participated in a DEI Change Group with Tribesy Consultants.

STUDENT VOICE: We continued to administer student surveys (CHKS, Engagement) and parent surveys (CHKS, climate, engagement) and analyzed data from these surveys to inform practice. Surveys were ongoing throughout distance learning and student voice was a big factor in planning and decision making regarding shifts in distance learning and possible reopening. Beyond surveys, student voice was solicited in google forms, focus groups, informal conversations, and through SSC student members.

Biggest change is not having the STAR program this year. We hope that LAPD will bring this program back in 21-22.

At elementary schools, the school site council must be constituted to ensure parity between (a) the principal, classroom teachers, and other school personnel, and (b) parents of students attending the school or other community members. Classroom teachers must comprise a majority of persons represented under section (a). At secondary schools there must be, in addition, equal numbers of parents or other community members selected by parents, and students. Members must be selected by their peer group.

      - b. Be based on academic achievement information about all students in the school, including all groups under §200.13(b)(7) and migratory children as defined in section 1309(2) of the ESEA, relative to the State's academic standards under §200.1 to—
        - Help the school understand the subjects and skills for which teaching and learning need to be improved; and
        - ii. Identify the specific academic needs of students and groups of students who are not yet achieving the State's academic standards; and
        - Assess the needs of the school relative to each of the components of the schoolwide program under §200.28.
        - iv. Develop the comprehensive needs assessment with the participation of individuals who will carry out the schoolwide program plan.
        - v. Document how it conducted the needs assessment, the results it obtained, and the conclusions it drew from those results.
  - B. Identification of the process for evaluating and monitoring the implementation of the SPSA and progress towards accomplishing the goals set forth in the SPSA (described in the Expected Annual Measurable Outcomes and Annual Review and Update).

## Requirements for the Plan

- II. The SPSA shall include the following:
  - A. Goals set to improve pupil outcomes, including addressing the needs of student groups as identified through the needs assessment.

- B. Evidence-based strategies, actions, or services (described in Strategies and Activities)
  - 1. A description of the strategies that the school will be implementing to address school needs, including a description of how such strategies will-
    - a. provide opportunities for all children including each of the subgroups of students to meet the challenging state academic standards
    - b. use methods and instructional strategies that:
      - i. strengthen the academic program in the school,
      - ii. increase the amount and quality of learning time, and
      - iii. provide an enriched and accelerated curriculum, which may include programs, activities, and courses necessary to provide a well-rounded education.
    - c. Address the needs of all children in the school, but particularly the needs of those at risk of not meeting the challenging State academic standards, so that all students demonstrate at least proficiency on the State's academic standards through activities which may include:
      - i. strategies to improve students' skills outside the academic subject areas;
      - ii. preparation for and awareness of opportunities for postsecondary education and the workforce;
      - iii. implementation of a schoolwide tiered model to prevent and address problem behavior;
      - iv. professional development and other activities for teachers, paraprofessionals, and other school personnel to improve instruction and use of data; and
      - v. strategies for assisting preschool children in the transition from early childhood education programs to local elementary school programs.
- C.
