## • AB 86: Covid-19 Relief and School Reopening Grants

Dr. Mora discussed the allowable expenditures for the AB 86 Grants.

- In-Person Instruction Grant allowable expenditures are:
  - COVID-19 testing
  - Cleaning and disinfecting
  - Personal protective equipment
  - Ventilation and other school upgrades for health and safety
  - Salaries for certificated and classified employees providing in-person instruction or services
  - Social and mental health support services provided in conjunction with inperson instruction
- Expanded Learning Opportunities Grant allowable expenditures are:

- Extending instruction learning time beyond requirements for the 2020-21, 2021-22, and 2022-23 school years.
- Accelerating progress to close learning gaps.
- Integrated pupil supports, such as mental health services, access to school meal programs, before and after school programs, and programs to address trauma.
- Community learning hubs that provide pupils with access to technology, highspeed internet, and other academic supports.
- Supports for credit-deficient pupils to complete graduation or promotion requirements and to increase or improve pupils' college eligibility.
- Additional academic services for pupils, such as diagnostic, progress monitoring, and benchmark assessments of pupils learning.
- Training for school staff on strategies, including trauma informed practices, to engage pupils and families in pupils' social-emotional health needs and academic needs.

The LCAP DCC team broke into groups to discussed the proposed actions and services for the Expanded Learning Opportunity Grant for 2020-21 and 2021-22 school year. They structured their input around the local measures and learning needs for English learners, Socioeconomically disadvantaged/low income students, homeless/foster youth, student with disabilities and at-promise students.
