- I. Call to Order – made by Iao at 5:34pm; Present: Gary Huff, Iao Katagiri, Jon Kean, Natasha Kingscote, Raven Kras, Laura Manson, Susan Samarge-Powell, Ben Swett; Absent: Laurie Lieberman
- II. Public Comments - None
- III. Approval of Minutes and General/Old Business – Minutes approved as written.
- IV. Board Information
 - a. Liaison Report – Board President Jon Kean shared that the board is focused most closely on reopening schools. SMMCTA negotiations were taking place and the board is looking for something solid to complete the school year. Hoping to have something for the 2021-22 school year as well. Vaccinations are also a big topic – the district is working with St. Johns and a nice partnership has formed. Hoping for an announcement soon from the Governor about educators and vaccinations. LACOE is saying we should not require vaccinations yet, but this may be something SMMUSD decides to do in the future. There will be a 2/24 facilities board meeting; would be important for Early Learning voices to be heard.
- V. SMMUSD Staff Reports (30)
 - i. In-School Work Hubs Update –
 1. Hubs continue; by 2/18 we will have 11 hub classrooms open, including one at LMS and two at JAMS; all staffed by CDS teachers and assistants. All will continue through at least spring break, but likely longer depending on the district's plans.
 2. Opened hubs to families in need (in addition to high priority groups); staff have made recommendations and families have asked for assistance.
 - ii. ITC, PK, SAP Update
 1. ITC opened on 2/1; have 5 toddlers plus 2 more enrolling
 2. PK opened on 2/1; have 20 students in two classrooms
 3. PK will continue with 90 students on Distance Learning
 4. PK still considering part-day classrooms, but unsure of interest
 5. SAP will remain on Distance Learning until further notice
