* Conducting of a district-wide needs assessment on a school-by-school basis (5 CCR11308[c][2])		
* Establishment of a district program, goals, and objectives for program and services for English learners (5CCR11308[c][3])		
* Development of a plan to ensure compliance with any applicable teacher and instructional aide requirements (5 CCR 11308[c][4])		
* If the DELAC acts as the English learner parent advisory committee under California <i>Education Code</i> Sections 52063(b)(1) and 52062(a)(2), the DELAC shall also review and comment on the development or annual update of the Local Control and Accountability Plan		
* Review of and comment on the school district's reclassification procedures (5 CCR 11308[c][6])		
* Review and comment on written notifications required to be sent to parents and guardians (5 CCR 11308[c][7])		
* The consolidated application must include certifications by appropriate district advisory committees, including the DELAC, that the application was developed with review and advice of those committees. (EC Section 64000[d])
