- 4. Shuli's update- SAMOHI outreach. Wellness workshops offered to 9<sup>th</sup> and 11<sup>th</sup> grade students. Flex time built into schedule to catch up on what is needed by student. Mindfulness training for teachers. Social-emotional wellness two day training for teachers— 50 attendees. Malibu applying for federal grants from SAMSA. Community schools initiative at SAMOHI going well—working on Vaping challenges. New provider coming to SAMOHI (Margret's Place) to provide clinical therapy services. New websites for all schools.
- 5. Susan's Update- 28 teachers trained by Planned Parenthood on comprehensive sex education. Curriculum implemented in secondary schools. Putting flyers on peach jar about where to get a free flu shot. Discussion around proactively advertising free flu clinics in October.
