Reclassification Criteria

Assessment of English Language Proficiency

- ELPAC
 - Use most current ELPAC score

Comparison of Performance in Basic Skills

- Local or state assessments to determine students are meeting academic measures in ELA
 - Use most current local or state score
- Teacher Evaluation
 - Use the student's academic performance as evidence of curriculum mastery
- Parent Opinion and Consultation

Reclassification Criteria

- Assessment of English Language Proficiency
 - Score of "4" on English Language Proficiency Assessment of California (ELPAC)
 - 2021-2022
- Comparison of Performance in Basic Skills
 - Meets or Exceeds standards on ELA Assessments
 - Elementary School Students:
 - Grades 1-2
 - Overall ELPAC Performance Level 4
 - score of 75%ile or above on two most recent Fastbridge aReading Assessments (2020-21 and 2021-22)
 - Grades 3 5
 - Overall ELPAC Performance Level 4
 - score of 75%ile or above on two most recent Fastbridge aReading Assessments Or
 - ** score of "3" or "4" on CAASPP in ELA

** Students do not have an ELA CAASPP score for 2020 - 2021

Reclassification Criteria

- Assessment of English Language Proficiency
 - Score of "4" on English Language Proficiency Assessment of California (ELPAC)
 - 2021-2022
- Comparison of Performance in Basic Skills
 - Meets or Exceeds standards on ELA Assessments
 - Grades 6th 9th
 - Overall ELPAC performance Level 4
 - - Score of 38% ile on most recent Star Reading assessment
 - Or

** Score of "3" or 4" on the ELA CAASPP

- Grades 10 12
 - Overall ELPAC Performance Level 4
 - Score of 38% ile on most recent Star Reading assessment
 - Or

** Score of "3" or 4" on the ELA CAASPP

SMMUSD Reclassification Criteria

Teacher Evaluation

- Teachers evaluate students on speaking, listening, reading and writing tasks in class.
- Teachers measure how well students express ideas clearly and communicate using academic language.
- Teachers also evaluate students' performance on classwork to ensure students are "on par" with English only peers

Parent Opinion and Consultation

- Parents/guardians meet with school administrator and staff to review student data and provide input.
- Secondary students are encouraged to attend reclassification meetings whenever possible.



Assessment of English Language Proficiency

- ELPAC or Alternate Assessment
 - Use most current ELPAC score or Alternate Assessment

Comparison of Performance in Basic Skills

- Local, state assessments or Alternate Assessment
- Determine students are meeting academic measures in ELA comparable with students with similar disabilities
 - Use most current local or state score

Teacher Evaluation

- Use of student's classroom performance information that is based on the students IEP goals for academic performance and ELD
- Inclusive of IEP discussion

Parent Opinion and Consultation

• Inclusive of IEP discussion

- Assessment of English Language Proficiency
 - ELPAC or Alternate Assessment
 - Use most current ELPAC score or Alternate Assessment
 - VCCALP (Ventura County Comprehensive Alternate Language Proficiency Survey)
 - Overall Level of English Proficiency Early Advanced (89 100) with subscores of Intermediate or higher (13 - 25)

Comparison of Performance in Basic Skills

- Local, state assessments or Alternate Assessment
- Determine students are meeting academic measures in ELA comparable with students with similar disabilities
 - Use most current local or state score

- Assessment of English Language Proficiency
 - ELPAC or VCCALPS (Ventura County Comprehensive Alternate Language Proficiency Survey)
 - ELPAC: Student has demonstrated progress on the subtests of the ELPAC that are NOT associated with the students qualifying disability

Comparison of Performance in Basic Skills

- Grades 1-2
 - score of 75% ile or above on most recent Fastbridge a Reading Assessments
- Grades 3 5
 - Score of 75% ile or above on two most recent Fastbridge a Reading Assessments Grades
 - Or
 - Grade 4 and 5
 - **Score of "3" or "4" on CAASPP or CAA in ELA

** Students do not have an ELA CAASPP score for 2020 - 2021



- Comparison of Performance in Basic Skills
 - Grades 6 9
 - Score of "3" or "4" on CAASPP

Or

 Renaissance Star aReading for 2020-2021 Score of 38%ile on a most recent assessment

Or

- California Alternative Assessment (CAA) English Language Arts.
- Grade 10 1
- 2
- Score of "3" or "4" on CAASPP
- Renaissance Star Reading for 2020-2021 Score of 38%ile on a most recent assessment

State Seal of Biliteracy Criteria

The State Seal of Biliteracy (SSB), marked by a gold seal on the diploma or transcript, recognizes high school graduates who have attained a high level of proficiency in speaking, reading, and writing one or more languages in addition to English.

| Criteria for proficiency in English: | Criteria for proficiency in a language other than English: |

| All requirements must be met. An overall grade point average (GPA) of 2.0 or above in English Language Arts classes 9-12 grade Achieving <u>either</u> a score of 40th percentile or higher on the Spring 2021, Fall 2021, or Winter 2022 administration of Star Reading <u>or</u> a 3 (Meeting Standards) or 4 (Exceeding Standards) on the Spring 2021 administration of CAASPP ELA. | ONE of the following must be met. Passing a foreign language Advanced Placement (AP) examination with a score of 3 or higher or an International Baccalaureate (IB) examination with a score of 4 or higher. Passing the SAT II Foreign Language Examination with a score of 600 or higher. Successful completion of a four-year high school course of study in a foreign (world) language with a 3.0 or above in that course of study. |
| * For English Learners (ELs): Achieve overall Early Advanced or Advanced proficiency level on the English Language Proficiency Assessments for California (ELPAC) | |

Seal of Biliteracy Timelines

- 2021-22 Timeline:
 - Now March 4: Disseminate information about Seal of Biliteracy
 - March 4: Deadline for students to submit the online application
 - March 4-17: Counselors/advisors review applications, follow up with students as necessary, and validate requests
 - Before graduation: Gold seal affixed to student's diploma



Next Steps

- Continue to implement reclassification criteria and support school sites by:
 - Monitoring EL students meeting eligibility criteria
 - Provide pre-populated RFEP forms to all sites
- Provide data reports to sites to support with Seal of Biliteracy identification
