Dear SMMUSD Families,

Starting next week, we will begin to open on-campus learning opportunities for some of our learners. We are excited to see our students return to campuses within the district. Below is the opening schedule for programs. Please note that we are phasing programs in as deemed appropriate. We have worked very hard to make sure we are following the lengthy and in-depth protocols required by the Los Angeles County Office of Public Health (LACDPH).

We will continue to offer Distance Learning for all those who wish to remain at home. Each program's hours and days of service may vary based on student need. If you have a student who will be returning to campus, your child's teacher will provide you with the schedule to follow.

Prior to your child's start date, you will be required to participate in an orientation session where we will explain screening protocols, cleaning protocols, personal protective equipment (PPE) requirements, and campus rules. Dates and times of the orientation will be sent to you prior to your child's return to campus. While we are very excited to have your child return to campus, we will strictly adhere to LACDPH guidelines for the safety of all.

All services such as Occupational Therapy, Physical Therapy, Speech and Language, Counseling, Orientation and Mobility, Deaf and Hard of Hearing support, Support for Visually impaired may remain in a Distance Learning format until further notice. We will reach out to individual families as more information becomes available for these services.

Your child’s teacher, your school’s special education coordinator, or a member of the educational services department will reach out to you as phases grow to see if you are interested in returning.

Many families have asked about the TK-2 waiver. We are in the process of applying for the TK-2 waivers. A reminder that LACDPH has authorized in-person instruction for TK-2 grade span as long as we implement specific safety protocols. However, schools must submit a waiver application for authorization. Initially, LACDPH required letters of support from bargaining units in order to accept the applications. Under this rule, it was primarily private schools that applied for and received authorization. A few public schools were able to apply and were granted the waiver with our neighbor the Las Virgenes USD, being one district that was successful in gaining approval. Since then, LACDPH has changed the requirement from having a letter of support to requiring consultation of the bargaining units. As a result, SMMUSD, like other districts in LA County, have consulted the bargaining units and are now submitting the application for a waiver. We are still in the process of negotiating with the bargaining units and hope to get an agreement as we wait for the result of our applications.
