Brontë Burnette – Santa Monica High School

Student Board Member Burnette reported that the grading period ends tomorrow. To celebrate, ASB held a spirit week this week and will host a pep rally tomorrow. The spirit week focused on the elements (earth, wind, water, and fire) for each day of the week. The End of the World-Vikings Survive Pep Rally will be tomorrow, and the whole school will be decorated as if they had survived the end of the world.

RECOMMENDATION NO. A.03b

It is recommended that the Board of Education approve a Head Start budget adjustment transferring program cost savings of \$306,000 to cover a fringe benefit rate increase and an increase in supply funds. This adjustment is warranted so that all Head Start funds are spent on direct services of children and families in the fiscal year in which funds are awarded as required by the Office of Head Start (OHS).

COMMENTS: During the Planning for the Measure BB projects it was established by the Board that the projects shall be designed to provide a healthy environment for students and staff. It was further established that the buildings shall be highly energy and water efficient to conserve natural and fiscal resources. To achieve these goals, on October 18, 2007 the Board adopted Resolution 07-07. Resolution 07-07 adopted the sustainability standards and principals of the Collaborative for High Performance Schools (CHPS) as a standard for design and execution of the Measure BB projects. Furthermore, the District set a goal to exceed the minimum CHPS points by 15% for all CHPS certified projects.

> CHPS is very similar to LEED in its building systems standards, credits, and procedures. However, CHPS also incorporates other standards and administrative processes tailored to educational spaces and implementation by school districts. Both CHPS and LEED require that buildings are properly commissioned. Proper commissioning is the most important process in insuring that the buildings meet the CHPS standards for efficient operation of building systems and maintaining healthy interior environments.

Commissioning has specific design phase tasks which includes multiple reviews of the design by the Commissioning Agent to verify proper system design and documentation. A detailed commissioning plan is also prepared during the design phase. Commissioning also has specific construction phase tasks which includes preconstruction coordination with contractors and field inspections during installation and oversight of the start-up and testing requirements, all of which are defined in the commissioning plan. The commissioning plan is incorporated into the construction documents to insure compliance of the contractor.

This Contract Amendment #10 is for Parsons to provide all of the design and project commissioning services for the Measure BB projects for the amount of \$1,325,000, for a total contract amount of \$29,217,931. To date \$187,211. has been spent on project design & commissioning with the major cost allocated to project commissioning. The design phase and construction phase commissioning budgets established in the Measure BB projects are sufficient for these expenditures.

COMMENT:

During work in the Programming Phase of the Measure BB projects it was determined that there was a total of seventy (70) projects from previous programs that were uncertified. Extensive research was conducted to verify the details and corrective measures required to achieve certification. Research included review of archives from the District and DSA, Federal Emergency Management Agency (FEMA) and Office of Emergency Services (OES). Project teams and the various project consultants were contacted, as well. This included architects and engineers-of-record, inspectors-of-record and testing labs.

As a result of the information gathered, corrective measures and action plans were implemented to complete the work and achieve certification. This included acquiring services of qualified architects, engineers, contractors, testing laboratories, and inspectors of records on the projects. DSA certification has been obtained for fifty-four (54) of the original projects, leaving sixteen (16) projects still needing certification.

DSA close-out certification efforts were not a part of the original Parsons programming contract. Certification of projects prior to the BB program is critical to achieving certification for current BB projects, as well as for future projects. A budget of 2 million for DSA compliance was presented to the BB Advisory Committee at the 01-11-10 BBAC meeting. A total of 1.8 million has been expended to date. An adjustment to soft cost & contingency will be made when the actual total cost of DSA compliance is known, at such time it will be presented to the board.

This Contract Amendment #11 is for the Parsons project manager to obtain DSA certification for the remaining sixteen (16) uncertified projects. This includes providing outstanding documentation for five (5) projects and developing and implementing action plans to certify each of the remaining eleven (11) projects. The proposed not-to-exceed cost for total DSA close-out certification is \$736,600. This includes \$436,600 spent as of January 31, 2011 and \$300,000 to complete certification of the remaining projects through 2012, for a total contract amount of \$29,954,531.

As a part of the Measure BB Science and Technology Building & Site Improvements Project, the 6th Street exit will be temporarily closed, thereby necessitating an alternate route for site access by heavy traffic vehicles for various M&O and joint-use facility permits. In conjunction with some CCJUP funding repairs to the field as a result of concentrated use during the installation of the synthetic field, improvements were made to Sealy Field as part of the Measure BB Science and Technology improvement to mitigate access to the campus for heavy traffic vehicles, site preparation for projects bicycle parking area and heavier field use as the closure of the softball field is underway. - (c) Within 60 days after the date of completion of the work of improvement, the retention withheld by the public entity shall be released. In the event of a dispute between the public entity and the original contractor, the public entity may withhold from the final payment an amount not to exceed 150 percent of the disputed amount. For purposes of this subdivision, "completion" means any of the following:
- (1) The occupation, beneficial use, and enjoyment of a work of improvement, excluding any operation only for testing, startup, or commissioning, by the public agency, or its agent, accompanied by cessation of labor on the work of improvement.

The last day contract work was performed on the project was November 22, 2011. All of the rooms are operational and being used by teachers. Therefore, the District has, through independent reviewers and site inspections determined beneficial use of the work on February 24, 2012 for each school site.

In order to facilitate the release of the retention being held by the District, a Notice of Cessation must be filed with the County of Los Angeles.

There are several outstanding items of the original scope of work that have not been completed. The District's estimate of the value of these items is \$10,642.48. A description of these items, and the District estimate, will be filed with the Notice of Cessation. If these items remain incomplete at the time the final payment is processed, 150% of the estimated value of the remaining items will be withheld from the final payment as prescribed in the Public Contract Code. At that time the District will engage another contractor(s) to complete the work.

RECOMMENDATION NO. A.17

It is recommended that the Board of Education revise BP 5117 – Interdistrict Attendance.

COMMENTS: The changes proposed in this revision were discussed by the board on February 2, and March 8, 2012.

It is recommended that the Board of Education consider rescinding the moratorium on new interdistrict permits in grades K through 11 and accepting new interdistrict permits at all schools. It is also recommended that the Board of Education consider increasing the capacity number of new interdistrict permits accepted and approved from 200 to 300 (Section E4) with the following considerations:

- The total number of new permits accepted and approved for kindergarten will not exceed 50
- The total number of new permits accepted and approved for grades 1 through 5 will be on a issued on a space available basis
- The total number of new permits accepted and approved for John Adams Middle School and Lincoln Middle School for grade 6 will not exceed 10
- The total number of new permits accepted and approved for grades 7 and 8 at John Adams Middle School and Lincoln Middle School will not exceed 10 per grade level per school
- The total number of permits accepted and approved for grades 9 through 11 at Santa Monica High School will not exceed 20 per grade level.
- Permit students will be accepted for Olympic High School on a case by case basis for students currently enrolled in SMMUSD
- The District will continue to accept all permit applications to Malibu schools.
- International High School students will be accepted and approved on a case-by-case basis.

It is recommend that the board consider a policy revision to clarify that students currently on an interdistrict permit do not have to annually renew an interdistrict permit. Staff is recommending that instead of submitting a permit renewal, continuing students annually submit a verification of continuing enrollment. Last year, the board revised this policy to comply with the new California law, AB 2444, which states that students who have obtained an interdistrict permit no longer need to reapply annually for a release from their resident school district.

It is also recommended that the Board of Education consider revising the current cut-off date of 2001-2002 (Section A) to enable SMMUSD students in good standing who were residents of Santa Monica or Malibu and have attended SMMUSD for a minimum period of three complete school years and subsequently move to another city, to be allowed to remain in the Santa Monica-Malibu School district as permit students.

Based on discussion from the March 8, 2012, board meeting, Mr. Allen suggested that grandchildren of district residents be added as a priority group. Ms. Freedman shared what she had discovered regarding Beverly Hills USD's process for verifying whether or not a student is a grandchild of a resident. Ms. Lyon added that the current Superintendent of Beverly Hills shared that when his district added this priority group to their policy, the first year of implementation saw a large amount of paperwork, but that it has leveled off since.

This policy will return for review next year to evaluate the new "grandchildren" priority group.

Ms. Lieberman MOTIONED to add the following priority group: "Grandchildren of individuals who have been living within the boundaries of SMMUSD for a minimum of five years, and grandchildren of: employees of the cities of Malibu or Santa Monica, alumni of Santa Monica High School, Malibu High School, or Olympic High School; and individuals working within the boundaries of SMMUSD.

Ms. Washington suggested that for the first year, the district accept applications from grandchildren of residents, and reevaluate the results in a year to determine if it should be opened up to grandchildren of the other priority groups. The board agreed.

INTERDISTRICT ATTENDANCE

A. Although students generally must attend school in the district and school where their residence has been established, the Santa Monica-Malibu School District Board of Education recognizes justifiable reasons for interdistrict permits. Upon request, the Superintendent or designee may accept students from other districts and may allow students who live within the District to transfer to another school within the District or out of the District.

Beginning with the 2005-06 school year permits will be issued on a year-to-year basis. Parents must reapply to SMMUSD and be accepted for continued attendance each year. must submit verification of continuing enrollment annually. Students enrolled prior to the 2005-06 school year on a PERT or DERT permit will not be affected by this change.

Involuntary loss of housing resulting from: apartments being removed from the rental market (Ellis Act), buildings being red-tagged, or evictions to accommodate owner-occupancy should not interfere with a child completing his/her education in the Santa Monica-Malibu Unified School District. The permit office will require the applicant to obtain verification from the Rent Control Department or other appropriate legal agency. These students will be allowed to remain in their schools for the remainder of the year in which their housing has been lost. In addition, they will be allowed to remain in SMMUSD as permit students in subsequent years provided they meet all the conditions of students attending SMMUSD on permit, and they reapply annually. The Ellis Act allows California apartment owners to evict tenants if the landlords intend to withdraw their units from the rental market.

SMMUSD students in good standing who were residents of Santa Monica or Malibu during the 2001-2002 school year, and subsequently move to another city, will be allowed to remain in the Santa Monica-Malibu School district as permit students, upon receiving a permit from their district of residence and meeting all the conditions of students attending Santa Monica-Malibu Unified School District on a permit.

Students "in good standing" who have been attending school/s within SMMUSD as a resident of the District for a minimum period of three complete school years, and subsequently relocate outside the boundaries of SMMUSD, will be allowed to remain in the Santa Monica-Malibu School district as permit students, upon receiving a permit release from their district of residence and meeting all the conditions of students attending Santa Monica-Malibu Unified School District on a permit. Permits will be granted per the language of section D below.

- B. Permits of this type are to be initiated by the student's parent or guardian who attests to the fact or shows evidence that the permit would be in the student's best interests.
 Cancellation of the permit shall occur if certain provisions are not adhered to by the student or parent/guardian, or if overcrowding should occur at the school of acceptance.
- C. The Board is committed to providing a quality education for all District students legally enrolled and will provide fair and consistent treatment for students and parent/guardians regardless of their residence or permit status. All applications for a permit will be treated in a fair and consistent manner.

- D. Final approval of permits for all students, including students needing specialized programs, such as GATE, special education, ELL, etc., shall rest at the District and shall be contingent upon space, budget and staff availability. The District will not pay excess costs to provide specialized services to students on permit.
- E. Except for the conditions listed below, effective September 2002, there will be a moratorium on the receipt of all new interdistrict attendance permits for schools in the Santa Monica-Malibu Unified School District. This moratorium shall continue through the 2014-15 school year with the following exceptions. The District will accept applications for interdistrict permits in grades K through 11. Permits will be granted per the language of section D. above.
 - 1. The District will accept applications for interdistrict permits to attend schools in the City of Santa Monica for grades K through 6 11 in order to stabilize the current number of interdistrict permit students in the District. Permits will be granted per the language of section D above. Regarding interdistrict permit applications for children of SMMUSD employees, please refer to section F2.
 - 2. Requests for new interdistrict permits will be accepted for all schools in the City of Malibu. Permits will be granted per the language of section D. above.
 - 3. No permits will be granted to attend Olympic High School.
 - 4.1. The total number of all new interdistrict permits that will be accepted and approved for the 2011-12 2012-2013 school year will not exceed 200 300. for the District.
 - a. The total number of new permits accepted and approved for kindergarten will not exceed 50.
 - b. The total number of new permits accepted and approved for grades 1 through 5 will be issued on a space available basis.
 - c. The total number of new permits accepted and approved for John Adams Middle School and Lincoln Middle School for grade 6 will not exceed 10.
 - d. The total number of new permits accepted and approved for grades 7 and 8 at John Adams Middle School and Lincoln Middle School will not exceed 10 per grade level.
 - e. <u>The total number of permits accepted and approved for grades 9 through</u>
 11 at Santa Monica High School will not exceed 20 per grade level.
 - f. Permits will be accepted to Olympic High School on a case by case basis for students currently enrolled in SMMUSD.
 - g. The District will continue to accept all permit applications to Malibu schools.
 - h. <u>International High School students will be accepted and approved on a case-by-case basis.</u>

- 5-2. All students currently attending on an interdistrict permit will be allowed to remain in the District until they leave or graduate, assuming that they <u>submit a verification of continuing enrollment annually reapply for a permit annually and comply with all the application requirements; and uphold appropriate standards of behavior, attendance, and academic effort. and that the conditions under which the current <u>initial</u> permit was granted have not changed. Interdistrict attendance permits for 11th and 12th graders may not be rescinded. although 11th and 12th graders must reapply for these permits annually.</u>
- 6.3. Guidelines previously applied to SMASH, Edison, including the immersion program through Grade 8, and our preschools will remain in effect.
- F. Requests for new permits will be received (granted) in the following order (Based on the timelines identified in Administrative Regulations 5117):
 - 1. Intradistrict permits allowing children who are residents of the cities of Santa Monica and/or Malibu to attend a school other than their neighborhood school;
 - It is the intention of the District to provide same-school placement for all siblings in a family once an intradistrict permit has been granted, except in cases where students need a specialized program which is only available on another campus.
 - If a district school receiving Title I funds is identified for program improvement, corrective action, or restructuring, all students enrolled in that school shall be provided an option to transfer to another district school or charter school. (20 USC 6316)
 - 2.3. Interdistrict permits for children of employees of the Santa Monica-Malibu Unified School District [certificated, classified, management, full and part-time (a minimum of 15 hours per week)];
 - It is the intention of the District to provide a seat in a District school (K-12) to all children of District employees who have requested a new interdistrict permit, with the understanding that Section D will be considered. Staff will do its best to accommodate requests for a specific school but will not guarantee requested placement. On-going permit holders are not affected and will continue in the home school being currently attended.
 - 3.4. If space, staffing and budget allow, interdistrict permits for:
 - a. Those students "in good standing" who have been attending school/s within SMMUSD as a resident of the District, for a minimum period of three complete school years, and subsequently relocate outside the boundaries of SMMUSD. Permits will be granted per the language of section D above.
 - b. Siblings of current interdistrict permit holders. who will be entering Kindergarten, 1st, 6th, or 9th Grade. If a permit is received (granted) there is no guarantee of same-school placement. On-going permit holders are not affected and will continue in the home school being currently attended.
 - c. International High School students on a case-by-case basis.
 - e.d. Children of employees of the cities of Malibu or Santa Monica.

- d.e. Children of full-time, permanent employees of Santa Monica College. enrolling in grades K-8.
- e.f. Children of alumni of Santa Monica High School, Malibu High School, or Olympic High School. Parent must attach a copy of graduation diploma to the permit application.
- g. Children of individuals working within the boundaries of SMMUSD.
- h. <u>Grandchildren of individuals who have been living within the boundaries</u> of SMMUSD for a minimum of five years.

RECOMMENDATION NO. A.21

It is recommended that the Board of Education approve the 2011-12 Second Interim Report and the corresponding budget adjustments.

COMMENTS: Education Code (*EC*) Sections §35035 (g), §42130, and §42131 require the governing board of each local educational agency (*LEA*) to certify at least twice a year as to the LEA's ability to meets its financial obligations for the remainder of that fiscal year and for the subsequent two fiscal years.

The 2011-12 First Interim Budget was adopted by the Board of Education on December 15, 2011 and was approved by the Los Angeles County Office of Education *(LACOE)*.

Since the adoption of the First Interim Budget, changing conditions have necessitated adjusting the District budget. All of the expenditure and revenue changes previously approved by the Board at the February 17, 2012 meeting or proposed for approval at this time are individually identified in the Second Interim Report (January 31, 2012), which is included as a part of this document.

The Second Interim Report was developed based on the following Revenue and Expenditure Assumptions.

REVENUE ASSUMPTIONS

2011-12 Midyear Cut (\$146,003) One time Revenue Limit (= .25% of Revenue Limit) (\$399,733) 50% of Transportation Revenue

2.24% statutory COLA for 2011-12 Revenue Limit funding.

The 2011-12 Base Revenue Limit for Santa Monica-Malibu USD is \$6,631.61 per average daily attendance (ADA) using the 2010-11 P2 ADA of 10,974. A **<20.004%>** deficit factor is applied to the Revenue Limit, and the adjusted Based Revenue Limit is \$5,265.36 per ADA. The total Revenue Limit is estimated to be \$59.326.267.

There is a (\$1,560,873) prior year Revenue Limit Adjustment budgeted to reflect the 2003-06 Revenue Limit offset for Redevelopment Fees. Funds have been reserved in the Redevelopment Fund for this adjustment and have been transferred to the General Fund to offset this adjustment.

The 2011-12 District Enrollment (CBEDS) is 11,344.

The Lottery allocation will be \$140 per annual ADA. This is made up of \$117 for unrestricted expenditures and the remaining \$23 is for Proposition 20 – Mandated for Instructional Materials.

The District will participate in the K-3 Class Size Reduction Program and receive \$1,071 per pupil, less the penalties for increasing class size to 25:1. The total projected revenue is \$2,202,811.

There is no COLA for Special Education funding. Adjusted Special Education funding is \$5,040.04 per ADA based on AB602. This amount reflects a reduction in SELPA funding due to the elimination of the statewide Special Disability Adjustment.

Special Education transfer from the Revenue Limit is \$1,837,046.

The 2010-11 Mandated Reimbursement revenue is \$157,555 as of January 31, 2012.

The Measure "R" parcel tax at \$358.91 per parcel is estimated to generate \$10,685,827, after processing senior exemptions.

The Estimated revenue from Prop Y is \$5,500,000 from the City of Santa Monica.

The District will receive \$7,953,227 of Joint Use Agreement funding from the City of Santa Monica.

The District will receive \$135,500 of Joint Use Agreement funding from the City of Malibu.

The combined lease revenue is \$2,610,748, which is from the DoubleTree Hotel, Madison Site, 9th & Colorado and 16th Street properties.

The estimated revenue from Facility Use Permits is \$816,403.

The estimated revenue of Tier III programs is \$4.3 million.

PTA Contribution from various schools is \$2,387,789.

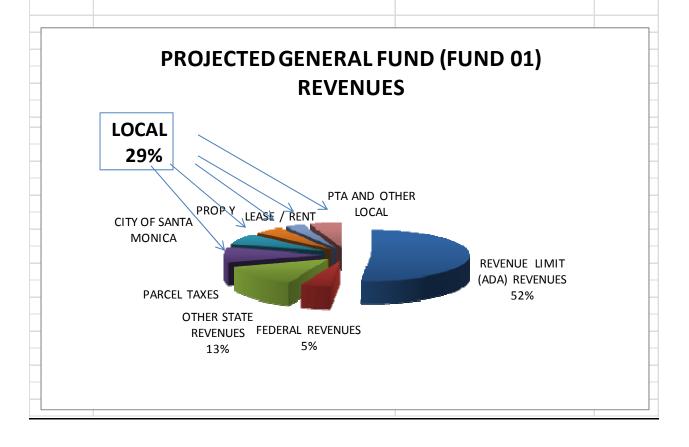

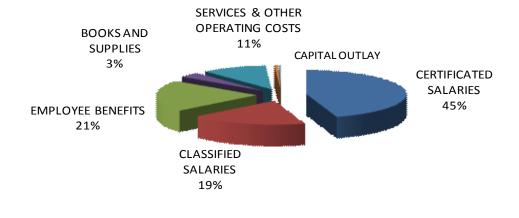

RESOLUTION NO. 11-25 HONORING CÉSAR CHÁVEZ

WHEREAS, As a farmworker, César Chávez experienced firsthand the injustice of working long hours with little pay. Instilled with a sense of justice passed down from his mother, he made a decision to speak up and fight for change. Chávez took part in his first strike in protest of low wages and poor working conditions for farmworkers. Although initially unsuccessful, his participation in that first strike was to mark the beginning of a long career in which he fought for improved working and living conditions for farmworkers; and

WHEREAS, In 1962, César Chávez resigned his position with the Community Services Organization to embark on a bold new undertaking to form a farmworkers' union. He was joined by Dolores Huerta, and together they became the architects of the National Farm Worker's Union, the forerunner to the present United Farm Workers (UFW); and

WHEREAS, In 1965, César Chávez led a strike of California grape pickers to demand higher wages, and urged all Americans to boycott table grapes as a show of support. The strike included a 340-mile march from Delano to Sacramento in 1966 in which thousands of farmworkers and supporters marched in solidarity; and

WHEREAS, César Chávez preached nonviolence to the strikers, even as they were physically abused by many of those opposed to the grape boycott. In 1968, he began a Ghandilike fast to call attention to the migrant workers' cause. Although his dramatic act

did little to solve the immediate problem, it increased public awareness of the conditions under which farmworkers labored; and

- **WHEREAS**, During the 1980s, César Chávez led the effort to call attention to the health problems of farmworkers caused by the use of certain pesticides on crops; and
- **WHEREAS**, In 1990, 300 Santa Monica High School students joined César Chávez in a peaceful protest in front of the Loews Hotel to stop the use of harmful pesticides;
- WHEREAS, On April 23, 1993, César Estrada Chávez died peacefully in his sleep in San Luis, Arizona; and
- **WHEREAS**, His life and work is not only an inspiration to Latinos, but to working Americans of all nationalities. His legacy lives on in the improved working and living conditions of hundreds of thousands of Californians and their families; and
- WHEREAS, In the year 2000, the California Legislature enacted Senate Bill 984 (Chapter 213 of the Statutes of 2000) to create an annual state holiday on César Chávez' birthday, March 31. This holiday provides all Californians the opportunity to learn from César Chávez' life, and provides schoolchildren the opportunity to learn through community service:

NOW, THEREFORE, **BE IT RESOLVED** by the *Board of Education of the Santa Monica-Malibu Unified School District*, that the District recognizes March 31, 2011, as the anniversary of the birth of César Chávez, and calls upon all schools to participate in appropriate observances to remember him as a symbol of hope and justice to all persons.

The MOU provides a collaborative effort for SMMEF to operate a fee-based and credit-earning High School Summer Program on the Santa Monica High School campus during summer 2012.

Comment: Due to the state's economic condition, many of the colleges and universities

have reduced their summer offerings to high school students including our collaborative partner, Santa Monica College. Many other school districts have utilized their education foundations to offer similar summer program to their respective students. By doing so, our students will be able to take "Ed Ahead" courses so that they can have more time to take other electives as well as be

better prepared to take AP classes during the regular school year.

This item was postponed from the February 16, 2012, board agenda. The MOU

will be made available at the meeting.

Dr. Escarce asked about fees. Ms. Gross listed the costs for full-fee, reduced lunch student fee, and free lunch student fee. The Ed Foundation also offers scholarships; approximately 20% of the students who took courses last year applied for and received scholarships. It is recommended that the Board of Education consider revising BP 5145.9 and adopting AR and Exhibit 5145.9 – Hate Motivated Behavior and Administrative Regulations

COMMENTS: The Hate Motivated Behavior policy has been revised and updated to include a definition of Hate Motivated Behavior and to establish Administrative Regulations for this policy. The policy revisions and Administrative Regulations were developed in conjunction with district staff, Health and Safety District Advisory Ad Hoc Committee members, members of the community and SMMUSD Risk Manager.

The Administrative Regulations specifies the types of conduct that would constitute hate motivated and how hate motivated behavior should be determined by staff. It also specifies the following:

- How a student subjected or witnessing this behavior should report to staff
- Elements of an investigation
- Notification of the parents and guardian
- Disciplinary Measures
- Support for Students
- Training of staff and students
- Reporting to District Office and Risk Manager
- District Record Keeping

Public Comments:

Joanne Berlin addressed the board regarding this item.

The board suggested the following language changes:

- Page 63: Strike out the paragraph that mentions personnel.
- Page 64: Records will be kept for five years. Add language that says the board will receive a report of hate-motivated behavior reports on a quarterly basis.
- Page 65 (form): Add a field showing whether or not the parent/guardian has been notified. Add to list of harassment types: "age" and "physical or cultural characteristics."

Ms. Freedman answered board members' questions about the complainant or the target meeting with the alleged harasser or person suspected of hate motivated behavior. The board asked about incidents in which the complainant or target was a group, rather than in individual. Mr. Mechur asked about Code of Conducts at the sites; Ms. Lyon said she would speak with the principals. The board suggested having a similar policy in which the alleged harasser or person suspected of hate motivated behavior is a district employee.

Students BP 5145.9

HATE-MOTIVATED BEHAVIOR

The Board of Education affirms the right of every student to be protected from hate-motivated behavior. It is the intent of the Board to promote harmonious relationships that enable students to gain a true understanding of the civil rights and social responsibilities of people in our society. Behavior or statements that degrade an individual on the basis of his/her race, ethnicity, culture, heritage, gender, sexual orientation, physical/mental attributes, religious beliefs or practices shall not be tolerated.

Definition of Hate Motivated Behavior

Hate motivated behavior is an act, or attempted act, motivated by hostility toward a victim's actual or perceived race, ethnicity, national origin, immigrant status, gender, sexual orientation, religious belief, age, disability, or any physical or cultural characteristics.(California Ed. Code Section 200.3 and section 422.55 of the California Penal Code.)

Hate-motivated incidents include those actions that are motivated by bias, but do not meet the necessary elements required to prove a crime. This may include such behavior as non-threatening name-calling, using racial slurs or disseminating racist leaflets.

Any student who feels that he/she is a victim of hate-motivated behavior shall immediately contact the principal or designee. If the student believes that the situation has not been remedied by the principal or designee, he/she may file a complaint in accordance with district complaint procedures.

Staff who receive notice of hate-motivated behavior or personally observe such behavior shall <u>immediately</u> notify the principal, Superintendent or designee, and law enforcement, as appropriate. Students demonstrating hate-motivated behavior shall be subject to discipline in accordance with Board policy and administrative regulation.

In addition, the district shall provide counseling and appropriate sensitivity anti-bias training and diversity education for students exhibiting hate-motivated behavior. The district shall also provide counseling, guidance and support, as necessary, to those students who are the victims of hate-motivated behavior.

The Superintendent or designee shall ensure that staff receive appropriate training to recognize hate-motivated behavior and methods for handling such behavior in appropriate ways.

The district shall provide age-appropriate instruction to help promote understanding of and respect for human rights.

Each school will adopt a Student Code of Conduct to be followed by every student at school or at school-sponsored or school-related activities.

At the beginning of each school year, students and staff shall receive a copy of the district's policy on hate-motivated behavior. Additionally, Principals or designee shall visit each student's classroom at the beginning of each school year to discuss consequences of violating this policy.

The district shall develop and implement guidelines designed to raise the awareness and sensitivity of teachers, administrators, and school employees to potentially prejudicial and discriminatory behavior and to encourage the participation of these groups in these programs.

Each teacher shall create and foster an environment that encourages pupils to realize their full potential and that is free from discriminatory attitudes, practices, events, or activities, in order to prevent acts of hate-motivated behavior.

HATE MOTIVATED BEHAVIOR

The Board of Education is committed to maintaining an educational environment that is free from harassment and discrimination of any kind.

Definition of Hate Motivated Behavior

Hate motivated behavior is an act, or attempted act, motivated by hostility toward a victim's actual or perceived race, ethnicity, national origin, immigrant status, gender, sexual orientation, religious belief, age, disability, or any physical or cultural characteristics.(California Ed. Code Section 200.3 and section 422.55 of the California Penal Code.)

Hate-motivated incidents include those actions that are motivated by bias, but do not meet the necessary elements required to prove a crime.

Types of conduct which are prohibited in the district and which may constitute hate motivated behavior targeted toward a victim's actual or perceived race, ethnicity, national origin, immigrant status, gender, sexual orientation, religious belief, age, disability, or any physical or cultural characteristics include, but are not limited to:

- 1. <u>Graffiti containing offensive language</u>
- 2. <u>Threatening or intimidating conduct</u>
- 3. <u>Jokes, teasing, rumors or name calling</u>
- 4. Slurs, negative stereotyping, and other hostile acts
- 5. Graphic material containing comments or stereotypes which is posted or circulated and which is aimed at degrading the target
- 6. A physical act of aggression or assault
- 7. Threatening phone calls, hate mail, cyber or other electronic communication
- 8. Vandalism or destruction of religious symbols or images
- 9. Other kinds of aggressive conduct such as theft or damage to property.

The determination of hate motivated behavior should be made when the behavior is judged by a reasonable person of the same protected group as the target to be sufficiently severe or pervasive to have a negative impact on the student's academic environment.

Investigation of Complaints Regarding Hate Motivated Behavior by Another Student

1. Notice and Receipt of Complaint: Any student, parent/guardian, or staff who believes a student has been subjected to hate motivated behavior or who has witnessed hate motivated behavior shall report to the school principal or designee immediately. Reports may be either oral or written. The school shall assist the student in the writing of the complaint if necessary.

2. <u>Initiation of Investigation: Principal or designee shall initiate an investigation of an allegation of hate motivated behavior within five school days of receiving notice of the incident, regardless of whether an informal or formal complaint has been filed.</u>

The investigation at the school site shall include interviewing:

- The student who is complaining
- The person accused of harassment
- Anyone who witnessed the conduct complained of
- Anyone mentioned as having related information

Factors to consider may include, but not limited to the following:

- Nature and scope of the incident
- Impact on the target
- Impact on members of the target's group
- Age of the target
- Age of the perpetrator
- Context in which the incident occurred

The complainant or the target shall not be required or asked to meet with the alleged harasser or person suspected of hate motivated behavior.

Principal or designee shall activate the school Threat Assessment Team to determine the level of threat posed to the target and need for safety supports. The school shall notify the parents/guardians of the following: the target/s, the student/s who made the report and the alleged perpetrator/s of the incident.

3. Reporting: The Principal or designee shall file an Incident Report to be submitted to the Risk Manager.

The principal or designee shall give the Director of Student Services a written report of the complaint and investigation. If the school verifies that hate motivated behavior occurred, this report shall describe the actions taken to end the behavior including appropriate disciplinary action, address the effects of the behavior on the target, and prevent retaliation or further incidents.

Disciplinary Measures

Any student who engages in hate motivated behavior of anyone at school or at a school-sponsored or school-related activity is in violation of this policy and shall be subject to disciplinary action.

Students in grades 4-12 who engage in hate motivated behavior shall be subject to discipline including, but not limited to, behavior contract, counseling, community service, suspension, expulsion, transfer to another school, transfer to an alternative program, or denial of participation in extracurricular or co-curricular activities in accordance with Board Policy and administrative regulation.

The Superintendent or designee shall notify local law enforcement as appropriate.

Any employee who engages in hate motivated behavior is in violation of this policy and shall be subject to disciplinary measures including but not limited to suspension, transfer to alternative job location, participation in counseling program, termination of employment.

Support for Students

The Superintendent or designee shall take appropriate actions to provide support for students who have been subjected or witnessed an act of hate motivated behavior.

- 1. The Principal or designee will make it clear to the affected student(s) and the parents/guardians that any form of retaliation or mistreatment of a student who complained will not be tolerated.
- 2. In instances where there were substantiated findings that a student was subjected to hate motivated behavior by a district employee or volunteer, the district will offer, and upon the request of the parent/guardian, will assist the student in receiving counseling intervention support.
- 3. The principal or designee shall also advise the target and the parent/guardian of any other resources and supports that may be available.

<u>Information</u>

The Superintendent or designee shall ensure that all staff receive training and all district students receive age-appropriate instruction and information on following regarding hate motivated behavior:

- 1. Acts and behavior which constitute hate motivated behavior;
- 2. <u>Encouragement for those subject to, and witnesses of, hate motivated behavior to report incidents immediately, and assurance that they will be protected from retaliation.</u>
- 3. Name(s) or title(s) of the person(s) to whom hate motivated behavior should be reported.

Notifications

A copy of the district's hate motivated behavior policy and regulation shall:

- 1. <u>Be summarized in the notifications that are sent to parents/guardians at the beginning of each school year (Education Code 48980; 5 CCR 4917)</u>
- 2. <u>Appear in any school or district publication that sets forth the school's or district's comprehensive rules, regulations, procedures, and standards of conduct (Education Code 231.5)</u>
- 3. Be summarized in the student handbook
- 4. Be provided to employees and employee organizations

Record Keeping

All reports will be forwarded to the Director of Student Services for record keeping.

- 3) Create and disseminate a climate survey to be used with students and parents to identify areas of success and areas for improvement
- 4) Consider the work of the Dialogue on Race and determine future opportunity for creating a public event that addresses issues of intercultural equity and excellence.

Public Comments:

• Janet McKeithen, Gary Avrech, and Sherri Walker addressed the board regarding this item.

Mr. de la Torre asked when the committee's first meeting would be held. Ms. Lyon replied that the goal was late April. Mr. de la Torre informed his fellow board members that the staff and board liaisons from this committee planned to meet prior to the first meeting. Mr. Patel asked what the board would like the DAC to be able to report back before the end of the school year. He suggested a board workshop with the committee. He suggested that discipline data also be included in the materials provided to the committee members. This is what a typical month at Grant looks like.

From September to June, Grant is a vibrant community where the buzz never ends. We are very proud of our ever-increasing Star test scores, our very successful SAI program, as well as, our community garden and nutrition program, just to name a few. The administration, teaching staff, students and parents work together to create a community school, where people actually like spending time together.

78% of our 2^{nd} - 5^{th} grade students scored proficient or advanced in language arts, 81% in math, and 86% in science. All major "subgroups" increased their test results this year.

A few of our SAI kids have had huge public successes this year, one earning a spot in Honor's Choir, one a seat on Grant's Student Council, and two spending a week on their own at 5th grade sleep-a-way camp. Many of the others have experienced substantial private gains, in the areas of academic success and social opportunities.

This year, a Grant Student was chosen to represent Santa Monica in the PTA reflections art show, aptly themed "Diversity Means" at the state level.

At Grant, we include everyone and it shows, in the look and feel of our community. We are diverse.

Despite this very rosy picture, you are all aware that there is another side to Grant, one that people tend to overlook.

- One in four of our students live in poverty.
- There are three major new low-income housing projects now underway in the Grant catchment, and we anticipate these numbers growing in the next year or so.
- We are currently at 26% Title I and receive 0 Title I funds to help "level the playing field for these children.

Our PTA operating budget for 2011-2012 is about \$250,000. We will spend over half of that on interventions for these children, in the form of:

- Homework Club
- Reading Classes (taught by credentialed reading teachers to students in grades 1-5, 90% of these are economically disadvantaged students.)
- Intervention Classes for over 125 students (before and after school)

If you are a poor student coming out of Grant, you will never realize a dollar of Title I money the district collects for you.

We are a very proud community that believes in helping support all of our students, which is why we have been so successful for so long, but times are changing.

With the introduction of centralized fundraising the opportunity came to speak openly about the challenges that Grant faces as we try to support all children, especially those who come from poverty. As PTA president, I hear from faculty and parents alike, a concern about why the district has passed over our children. Aren't all children worthy?

You (The Board) are aware of our unique situation and therefore we ask you to consider the following:

- Smaller class sizes like our Title I cohorts
- · Reading and Math intervention support
- Help funding Arts enrichment (PS Arts, Ballroom Dancing)
- Help purchasing Technology to run innovative intervention software (our computers are 6 years old and don't support new programs like Rosetta stone)
- Restoring a full time AP position at Grant

Today, Grant held it's 17th annual Jogathon. It was spectacular! This event encapsulates the spirit of our school:

- Pioneering- Grant was the first school in the district to have a Jogathon.
- Supportive & Enthusiastic- Over 150 parent volunteers, grandparents, and local business leaders came to cheer on our students.
- Caring- Students ran in class teams but also encouraged one another to meet their personal best.
- Inclusive- All of our students, from preschoolers to children in special education, ran together as Grant Geckos

When you start off the school year making your principal kiss a pig and dye his hair blue, you just might jeopardize the PTA-Principal relationship. Well, we're happy to report that the collaborative spirit is still well and good at Rogers and, working together, we've accomplished some great things.

First, let's speak about the academic environment. Parents love Rogers for the innovative teaching techniques used. The STEM focus, CGI Math, RCT (Reading Comprehension Time), Writers Workshop, and Responsive Classroom are all great examples. These differentiated learning opportunities truly allow teachers to meet students where they are and move them forward. Everyone is challenged and engaged, no matter their academic level.

We just can't say enough, how important the STEM focus is, and in particular, the opportunities afforded in the STEM lab. There, the students are challenged to investigate their world by asking questions, conducting experiments, analyzing data and writing about what they've discovered. It's hands-on learning across all the disciplines and it prepares students to thrive in our technology focused 21st century.

Parents continue to support the academics by volunteering time in the classroom and working with their children at home. That's the good stuff. The issues around the achievement gap, NCLB, and PI status are bigger than we can address here. But greater support around math and reading specialists, homework clubs and after school tutoring could really help.

Now let's address the physical campus. Improving the play yards at Rogers has been an amazing collaboration between the district, administration, parents and staff. Combining resources we were able to remove unsafe und unsightly equipment from our first grade yard and replace it with a newer structure from Edison Elementary. We purchased new picnic tables, resurfaced and restriped a large portion of our blacktop, and installed a new shade structure. It's made a huge difference in the play spaces.

Parents also raised funds and helped design and build a new library check-out desk, which looks amazing! We've also raised the funds to replace the unsightly stage curtain in the cafetorium. While all of this is great, the job is not complete. To help keep us moving forward, we've created two new committees with unique visions for our school campus; the Green Team and the Facilities Improvement Committee. These groups, made up of parents, students and staff, are working hard to zero in on some sustainable, real solutions to help us both beautify our campus and make us a more eco-friendly place.

We know that Rogers is an amazing place for a whole host of reasons, and our continual challenge is combating the unwarranted negative reputation that comes along with a community as diverse as ours; and a physical campus that needs some TLC. With the District's help, we will continue to meet the needs of students and improve the campus.

Multi-year Assumptions

- State revenue Cost of Living (COLA) increases of 3.17% (2012-13) and 2.40% (2013-14); State deficit increasing from 19.754% to 22.22% each year eliminating the affect of the COLA
- CPI increases apply to the parcel tax revenue
- Moderate increases projected for revenue from Prop Y
- A tax measure does not pass and the \$370/ADA trigger is pulled
- Student enrollment stable at 11,292

Multi-year Assumptions - continued

- The Board will approve the \$2.3 million dollar reduction plan for the 2012-13 budget as presented at the Board workshop on February 18th
- If necessary, the Board will approve another \$1.0 million dollar reduction plan for the 2013-14 budget
- Employee health and welfare increases of 7.0%
- Step and Column increases of 1.50%
- There will be unexpended budget allocations in each of the fiscal years 2011-12 through 2013-14 of \$2.0 million dollars
- The Reserve for Economic Uncertainties of 3.0% each year

Multi-year Challenges

- The District will be able to meet its obligations in the current and next two fiscal years.
- <u>However</u> challenges continue in the future.

AGREEMENT BETWEEN

SANTA MONICA-MALIBU UNIFIED SCHOOL DISTRICT (SMMUSD)

AND

SANTA MONICA-MALIBU EDUCATION FOUNDATION (SMMEF)

This AGREEMENT is made and entered into this 15th day of March 2012 between SANTA MONICA-MALIBU UNIFIED SCHOOL DISTRICT, also known as School District, and the SANTA MONICA-MALIBU EDUCATION FOUNDATION, also known as Education Foundation. The program described in this Agreement shall be known as the Santa Monica-Malibu Education Foundation High School Summer Program ("Foundation Summer Program").

RECITALS

- 1. The School District and the Education Foundation have been supporting students in the Santa Monica and Malibu areas collaboratively for many years.
- 2. The School District serves as the oversight and governance entity for the students in the Santa Monica-Malibu areas.
- 3. The Education Foundation is separate and apart from the Santa Monica-Malibu Unified School District.
- 4. The Education Foundation is a 501(C)(3) non-profit organization, has its own Board of Directors, conducts fund-raising for programs benefiting all students in the School District, and operates various programs including summer programs.

ESTABLISHMENT OF PROGRAM

The School District and the Education Foundation jointly agreed to continue the Education Foundation High School Summer Program for high school students beginning in the summer of 2010.

RIGHTS AND RESPONSIBILITIES OF PARTIES

- 1. The Education Foundation shall have the sole responsibility to manage the Foundation High School Summer Program, including student recruitment, enrollment, and registration; and the overall administration of the Education Foundation High School Summer Program.
- 2. The Education Foundation shall have the sole responsibility to manage the recruitment, hiring, and compensation of teachers working for the Education Foundation High School Summer Program.
- 3. The Education Foundation shall enter into a Facilities Use Agreement with the School District under the Civic Center Act.
- 4. The School District and the Education Foundation shall share facilities and administrative support during any time when the Foundation High School Summer Program and the School District's own summer program are both taking place in the same location.
- 5. The School District shall permit the acceptance of earned high school credits from coursework offered in the Foundation High School Summer Program and taught by teachers who have appropriate credentials and utilize District curriculum and instructional textbooks and materials.

DATES OF 2012 EDUCATION FOUNDATION HIGH SCHOOL SUMMER PROGRAM

The Foundation High School Summer Program shall operate Mondays – Fridays from June 25, 2012 to July 31, 2012 inclusive (July 4 is a national holiday). These dates may only be changed by agreement of all parties.

EXPENSES AND/OR COST TO THE DISTRICT

There are no extraordinary expenses that the School District or the Education Foundation assumes under this Agreement.

FINGERPRINTING REQUIREMENTS

Education Code Section 45125.1 states that if employees of any entity providing school site administrative or similar services may have any contact with any under-age pupils, those employees shall be fingerprinted by the Department of Justice (DOJ) before undertaking any services to determine that they have not been convicted of a serious or violent felony. If the School District determines that more than limited contact with students will occur during the performance of these services by parties under this Memorandum of Understanding, parties will not perform services until all employees providing services have been fingerprinted by the DOJ and DOJ fingerprinting clearance certification has been provided to the School District.

The Foundation High School Summer Program employees shall be subject to the requirements of the above-referenced Section. It is understood that all faculty and staff members who shall be employed by Foundation High School Summer Program have obtained fingerprinting clearance because they are current School District employees and fingerprinting is a routine employment requirement for District employees.

HOLD HARMLESS CLAUSE

The parties to this Agreement agree to hold harmless and to indemnify the School District and the Education Foundation from every claim, demand or liability, which may be made by reason of:

- A. Any injury to person or property sustained by the School District and the Education Foundation, upon or in connection with the work called for in this Agreement, however caused.
- B. Any injury to person or property sustained by any person, firm or corporation caused by an act, neglect, default, or omission of the School District or the Education Foundation, upon or in connection with the work covered by this Agreement, whether the said injury or damage occurs upon or adjacent to the work location. The School District and the Education Foundation, at their own expense, cost, and risk, shall defend any and all actions, suits, or other proceedings that may be brought or instituted against the School District or the Education Foundation, on any such claim or demand, and pay or satisfy any judgment that may be rendered against the School District or the Education Foundation, in any action, suit, or legal proceedings or results thereof.

ASSIGNMENT

This Agreement may be reviewed, modified, or revised as appropriate at the request of any one of the parties to ensure appropriate provisions of services. No party to this Agreement may make any change to this Agreement or any part thereof without the prior written consent of each the other parties.

TERMINATION

Any party may terminate any part or the entire part of this Agreement upon providing written notice to each of the other parties no less than thirty days before the start of the Education Foundation High School Summer Programs. To prevent any disruption to students, no party to this Agreement may cease performing its obligations under this Agreement once the Foundation High School Summer Program begins unless such obligations have been determined to be contrary to any established laws, policies and/or procedures that a party must adhere to.
