1. Matthew Ware – Santa Monica High School

Student Board Member Ware reported that No Shave November will end soon. TEDxYouth was at Barnum Hall this past Saturday. Students from the City of Industry’s TEDxYouth attended in order to learn how they could model theirs after ours. Girls’ volleyball and boys’ water polo made it into the second round of CIF playoffs, and a couple individual track members and tennis players are still competing in CIF. The Roberts Art Gallery continues to host exhibits of student work. Samohi Theater recently showed a production of Noises Off. The school has partnered with the City of Hope for a blood drive on November 25. Regarding a proposal Dr. Kelly made at the last meeting about bringing peer mediation to the high schools, many students at Samohi are very supportive of the idea.

2. Michael Jacobson – Malibu High School

Student Board Member Jacobson reported that No Shave November is almost over. The boys’ water polo team has a 29-0 record, and Mr. Jacobson invited everyone to come out and support them in CIF finals this Saturday in Irvine. ASB hosted the biannual blood drive with UCLA. The Laramie Project performance starts tonight. Seniors are working on their college applications. On November 19, the college counselor hosted an ice cream college application celebration during lunch. Club Day is next Tuesday, during which the approved clubs can raise money for their activities.

3. Amanda Huffman – Olympic High School

Student Board Member Huffman reported that on October 29, Olympic HS completed its model school evaluation and received great compliments from the review committee. Math teacher, Mr. Bushin, attended the California Math Conference in Palm Springs on November 2. The Youth Improvement Seminar (YES) class has

made its way from Ms. Siemer's classroom to the garden as the students learn breathing techniques to connect mind and body as a means of helping students cope with stress and emotions. Students really enjoy the class. Students took the CAHSEE on November 5 and 6. A counselor from SMC spoke to seniors about SMC, financial aid, the assessment test, and career paths. Ms. Siemer's Criminal Justice class took a field trip to Homeboy Industries on November 14. On November 19, actors from the Play-writing class performed plays written by the students. Ms. Huffman reported that it was a wonderful assembly and the whole school enjoyed it. Beginning yesterday, the school's yearbook staff started conducting interviews with teachers. Mr. Suminski's Career Exploration class received a wood lathe through a generous grant from DonorsChoose.org, which was fully funded by Chevron Corp. The school is also working to get a compressor that will support the sand-blasting unit it received two months ago; Mr. Suminski is currently funding this item. The newest goal is to get a 3-D printer, and the school will begin a marketing push to get pledges to fund this purchase.

B. SMMCTA Update – Mr. Harry Keiley (5)

Ms. Braff delivered the report for Mr. Keiley. She commented on the earlier discussion from the study session about keyboarding. She said she was excited to hear the information about preschool that will be presented under Item No. D.04. Ms. Braff congratulated Roosevelt, Franklin, and Webster Elementary Schools for being invited to apply for the 2014 California Distinguished Schools. She reported that as of this morning, her calculations show that eleven classrooms in grades 9 through 12 have over 40 students. She commented that the Professional Learning Communities (PLCs) training was great. Ms. Braff reported that teachers she has spoken with feel overwhelmed regarding implementing the new Common Core State Standards. She said teachers would like more planning time.

D. PTA Council – Ms. Patti Braun (5)

Ms. Braun invited board members and senior staff to the PTA Council holiday breakfast on December 10 at Duke's in Malibu. She commended parent leaders in Malibu for their leadership during the environmental concerns as well as the dedicated work of the task force. She also congratulated Roosevelt, Franklin, and Webster Elementary Schools for being invited to apply for the 2014 California Distinguished Schools. Ms. Braun thanked Gary Bradbury for presenting information to the PTA Council on disaster preparedness and lockdown procedures. The PTA leaders said they were impressed with the thoughtful work the district has done since the shooting in Santa Monica in June. At the full council meeting earlier this week, Craig Foster from AMPS presentation information on the Malibu unification process. Council members asked questions, particularly about the timeline, indemnification, fundraising, and how a separate school district would be in the best interest of the children. PTA is working hard to make these next eleven weeks count for Vision for Student Success. Ms. Braun remarked that the Education Foundation has been incredibly responsive and inspiring. She said she was honored to receive the commendation tonight from the board, and that collaborating with the Educational Services Department in creating the Common Core webinars was a great experience. She explained more about the School Smarts Academies.

A. Asst. Supt., Educational Services – Dr. Terry Deloria (5)

Dr. Deloria reported that the first cohort of Professional Learning Communities training was held last Friday. Dr. Muhammad has agreed to return for a second training session. Members of the Educational Services Department team attend the first ever STEM symposium in California. They came back with great ideas for pre-K-12. In regards to the Equity and Access goal, Dr. Edeburn and Ms. Gonzalez-Castillo did a wonderful job presenting to the principals about cultural proficiency. The principals will take this information back to their sites and ask their teachers difficult, important questions about student achievement. Mr. Patel wondered if the board would be interested in having a STEM conversation at a future meeting. Dr. Deloria replied that a STEM study session was scheduled for the May 1 board meeting.

B. Assoc. Supt., Business & Fiscal Services/CFO – Ms. Janece Maez (5)

Ms. Maez reported that she is attending a statewide CBO symposium today and tomorrow. The symposium, sponsored by CASBO, brings in experts and hosts breakout sessions on topics about current state initiatives. Kevin Gordon from Capital Advisories Group presented information on the legislative and political pieces as the state moves forward with LCFF/LCAP. Deputy Legislative Analyst Jennifer Kuhn explained how the sunset of Proposition 30 will affect future budget forecasts and how the sunset of the “triple flip” will impact the distribution of funds to school districts. One of the breakout sessions was almost identical to what Dr. Bradford and Ms. Mangle presented during tonight’s study session. Following Tuesday’s workshop with School Services of California on Tuesday regarding the LCFF/LCAP, presenter Sheila Vickers said we should be proud as district first for hosting the workshop and second for the great turnout.

C. Asst. Supt., Human Resources – Ms. Debra Moore Washington (5)

Ms. Washington announced that this coming week will be the second meeting of the New Administrators Assembly. Nine seated administrators and eight aspiring administrators attended last time; there will be two new aspiring administrators attending this second meeting. The topic of this upcoming meeting is formative and summative assessment. Ms. Washington reported that her department had received over twenty applications for the McKinley principal position. The district has reached out to colleges and universities to form a conduit for the best and brightest teachers to come to SMMUSD. Today, Ms. Washington met with Dr. Irene Oliver at Loyola Marymount University to create connections for teachers graduating this winter and next spring. The Human Resources Department has been working diligently on the Affordable Care Act and has held two kick off meetings for the workforce analysis. The district is looking forward to continuing to work with both unions and Interest Based Bargaining.

D. Superintendent – Ms. Sandra Lyon (5)

Ms. Lyon said that the presentation and video from the LCFF/LCAP meeting will be posted online. She reminded board members that that was just the first meeting; the district office and principals will be working to inform the community about the process and information. Yesterday, Ms. Lyon presented the district’s goals to the Santa Monica Early Childcare Task Force. The task force was interested in the fact that the district hired a director in charge of pre-k-5 curriculum. Ms. Lyon reminded board members

that the Vision for Student Success phone-a-thon would be held December 2-13. Ms. Lyon encouraged everyone to attend the numerous visual and performing arts events occurring throughout the district leading up to winter break. During the month of December, the district will be collecting nonperishable foods for the Westside Food Bank. The district will be closed Thursday and Friday next week for Thanksgiving. Ms. Lyon wished everyone a happy Thanksgiving.

STUDY SESSION ITEM NO. S.01

With the passage of recent legislation, the California Department of Education is making substantive changes to the assessment and accountability systems for all public schools.

AB 484 stipulates that as of January 1, 2014, most of our current Standardized Testing and Reporting (STAR) system of CST and CMA assessments will be replaced with the California Measurement of Academic Performance and Progress (CalMAPP). CalMAPP consists of the new Smarter Balanced on-line tests designed to assess students' achievement of Common Core State Standards in English language arts and mathematics. Certain components of STAR will remain in place for this year and next. These components include the science tests at grades five, seven and ten, as well as the CAPA assessment for students in grades two through eleven. Eleventh graders will still have the option this year to take the STAR (CST) tests for the purpose of the Early Assessment Program (EAP) in order to gauge their readiness for college-level English and math coursework. In 2015, and readiness score will be derived from Smarter Balanced.

The Smarter Balanced on-line assessments will be fully implemented in the 2014-15 school year. This spring, however, all California students in grades three through eight, and in grade eleven, will be required to participate in a Smarter Balanced field test in either English language arts or mathematics. The purpose of the field test is to "test the test" and the technology systems in place to support on-line assessment. The field tests will not yield individual student, school or district results. For this reason, schools' API and AYP standings will be frozen at their 2013 levels.

This study session will provide information to the Board of Education and the public about the steps SMMUSD is taking to prepare for the Smarter Balanced field tests this spring and for full implementation in 2014-15. These steps include: an inventory for each site of existing hardware and infrastructure; calculation of the number of computer workstations needed to accommodate student testing; purchase of new equipment where needed; training of school site test coordinators, administrators, teachers, and tech support personnel; and development of parent and community education pieces.

Dr. Bradford and Ms. Mangle's presentation can be found under Attachments at the end of these minutes.

Dr. Bradford answered board members' questions about how the district was preparing students to take the online test, including bringing back keyboarding and teaching critical thinking to answer Select All That Apply types of questions. Mr. Patel wondered how districts will know how prepared their students are for these new test if they do not receive the results of the field test. Dr. Bradford said the consortium has made it very clear that the results will not be released. She said that while it is important to teach the students how to take the test online, she stressed the importance of focusing on classroom instruction. Mr. Mechur asked about students who don't have technology at home to take practice tests. Dr. Bradford said there will be a digital divide that will need to be addressed. Dr. Escarce asked about free response questions in the math tests. Dr. Bradford replied that it consists mostly of students selecting an answer and then explaining their choice.

In late October 2013, a gas leak was detected at the Roosevelt Elementary playground site. The Gas Company came out, tested the main gas line and confirmed that there was a leak. The Gas Company shut off all gas service to the site until repairs were made. This gas line is believed to be the original 4" galvanized pipe that was installed in 1938. All repairs were made and completed by November 17, 2013, restoring both heat to the classrooms and on site cooking.

A payment bond and all other required construction documents will be furnished for this project.





Mark Katchen, the environmental consultant hired to coordinate testing at Malibu High School and Cabrillo Elementary School and facilitate the meetings of the Malibu Schools Environmental Task Force, will update the Board of Education about the testing protocol, current results, and present some options the District may consider to address any environmental or air quality concerns discovered during the testing process.

Ms. Lyon updated the board on recent activities related to the environmental concerns at Malibu High School and Cabrillo Elementary School. She introduced the Malibu Schools Environmental Task Force members. Dr. Cyrus Rangun from the Department of Public Health explained that the department sent out a questionnaire to Malibu HS staff about any health concerns they might have. The department will examine the testing data once the district receives it and get back to the district with its impression. Ms. Lieberman asked Dr. Rangun for his preliminary impressions. Dr. Rangun said the department does not see any overt environmental emergency, but there is still room for more investigations in order to conduct a comprehensive approach to the concerns. Ms. Lyon stated that after speaking with the EPA regarding the cleaning process, it is apparent that the district does not have the capacity to conduct the cleaning; therefore, it will be necessary to bring in professionals to help with the cleaning and community outreach. Mr. Mechur and Ms. Lieberman commended Ms. Lyon for her leadership during this time while simultaneously maintaining instructional leadership. Ms. Lyon replied that it has been a team effort and the task force has been a valuable part of the process.

Dr. Deloria said would like to move forward with fiscal feasibility piece before determining a timeline. She explained the difference between preschool and transitional kindergarten. Mr. Patel asked if districts could use LCAP funds for preschool programs. Ms. Maez replied that while LCAP funds would not be used for preschool programs, general fund monies could be used. She reminded the board, however, that the general fund budget is limited; if a neighborhood preschool program is to be funded, then other program budgets will be affected.

RECOMMENDATION NO. A.22

It is recommended that the Board of Education approve the allocation of \$60,000 from the Equity Fund to the Educational Services Department for supporting 2013-14 summer school. Staff also recommends that all remaining funds be allocated to sites since this is the year where schools must meet both PTA and VSS fundraising goals.

COMMENTS: The Equity Fund was established to improve the achievement of all students while simultaneously closing the achievement gap by mitigating the effects of the inequitable enrichment resources to schools. AR 3290 allows the distribution of the fund to:

1. Support district-wide initiatives to provide academic support, intervention and/or remediation in accordance with the mission of the school district;
2. Support school sites using the weighted-student formula for distribution of fund;
3. Reserve resources within the fund.

The 2013-14 Equity Fund total of \$506,382.38 was generated by the following:

- Schools collectively contributed \$322,087 from 2012-13 fundraising activities and gifts.
- \$184,295 of unspent Equity Funds were carried over (including reserve) to the current funding year.

Attached is the weighted distribution chart based on the student demographic and achievement data.

Dr. Deloria answered board members' questions about the carryover. Ms. Lieberman answered Mr. Patel's question about these funds being a part of the last year of the equity fund model.







- **For full implementation of Smarter Balanced in 2014-15, we will need between 240 and 250 additional computers in order to complete testing within reasonable time frame (10 days).**
- **For the field tests this spring, we will need about half that amount or 120 – 125, since students will only test in one subject area.**

What Is the EDI?

- The Early Development Instrument (EDI) is a population measure of how young children are developing in communities in the United States.
- The EDI measures five areas, or domains, of early childhood development:
 - *Physical health and wellbeing,*
 - *Social competence,*
 - *Emotional maturity,*
 - *Language and cognitive skills, and*
 - *Communication skills and general knowledge.*



How Can EDI Data Be Used?

- Compare the strengths and weaknesses in children's development and school readiness across communities and EDI domains
- Understand the relationship between children's EDI results and other important factors that may influence their health and well-being
 - *Poverty,*
 - *Mobility*

Is the EDI Valid and Reliable?

- EDI has been established as a psychometrically adequate indicator of child well-being during the kindergarten year.





- Recent data show SES differences in language processing skill and vocabulary at 18 months
 - SES 5-year-olds children scored more than two years behind non-SES children at kindergarten entry
 - Between 18 and 24 months, SES toddlers learned 30% fewer words than non-SES toddlers.
 - Gist: When SES student start kindergarten so far behind, its nearly impossible for them to catch up — especially because they are more likely to regress each summer.

Oklahoma's Universal Preschool

The Tulsa pre-K program has generated phenomenal improvements in school readiness.


