## Board of Education Regular Meeting – Thurs, September 3, 2020

### **The board discussed the following:**

- Staff presented information on Samohi's PPBL Pathway, including enrollment numbers, survey and focus group results, informal data regarding bright sports and areas for growth, and recruitment strategies for 2020-21.
- The board discussed proposed language changes to its board bylaw regarding start of board member terms.

### **The board took action on the following:**

- The board approved the 2020-21 charges for the Financial Oversight Committee.
- The board approved the 2019-20 unaudited actual budget report, which is an annual item.
- In response to the COVID-19 pandemic, our district has been procuring personal protective equipment, thermometers, and other necessary equipment. The board adopted a series of resolutions in March and May allowing these purchases to be made without the usual bidding process or pre-approval from the board. When this occurs, the board takes action to renew this emergency resolution, with the list of purchased materials attached to the agenda item.
- The board adopted a new policy regarding property loss and damages.

### **Special note:**

- During his report, Dr. Drati provided a COVID-19 update, which he will now be doing at board meetings. His report included information on feedback he's received about distance learning, how our district is simultaneously planning to meet all of the county's protocols for reopening schools (once the county allows for reopening), and the small cohorts of high-risk, high-needs students for which the county has allowed.
- The board adjourned its meeting in memory of Mike Donovan, a retired teacher who had been with our district for 37 years.
