Ms. Maez informed the committee that a preliminary budget presentation will be made to the Board of Education at the June 2, 2016 Board meeting. The district budget committee is scheduled for an initial kickoff on Wednesday, June 15, 2016. The meeting will start the process and establish a schedule of meetings for the following years; outlining the areas that will be addressed. The second interim budget shows about \$7M deficit in the out years. This number has since grown by about \$3.5-\$4 million. Mr. Sweetmore and Mr. Jacobson will forward to Ms. Maez contacts for a potential facilitator to the budget committee.
