### **VIII.** Public / Committee Comments

Mr. Jacobson reported that the sustainability subcommittee spoke to Purchasing Director Virginia Hyatt regarding energy efficiency and water issues. The Malibu assessments being completed will be paid by the District. The Santa Monica assessments are forthcoming and will be paid for out of a City of Santa Monica grant.

Ms. Maez reported that the Board of Education discussed heating and air conditioning study at the September 1, 2016 Board meeting. That discussion included projected energy increases.

Ms. Maez thanked the FOC Financing subcommittee for coming together quickly for a meeting with Keygent regarding the bond refunding. The calls with the rating agencies reaffirmed the District's ratings and the presale call is scheduled for Monday, September 12, 2016 with the bond sale on Tuesday, September 13, 2016. This should yield approximately \$14M savings to taxpayers.
