5. Public Comments

a. Public Comments is the time when members of the audience may address the Committee on items not scheduled on the meeting's agenda. All speakers are limited to three (3) minutes. - b. Measure SMS Updates
 - i. Measure SMS Financial Report as of June 30, 2022– Mr. Massetti reviewed this report with the committee.
 - ii. Samohi Projects Mr. Massetti updated the committee on the status of the construction noting the planned opening at this time is August 2024.
 - 1. Exploration and Gold Gym, Construction Update
 - iii. District-wide FF&E Upgrades Mr. Massetti updated the status of upgrades. The committee requested to see photos of the new furniture on the school sites.
 - iv. Muir/SMASH Water Intrusion Mr. Massetti provided an update noting that a water intrusion specialist was hired along with a team of experts. Their analysis showed that we don't need to replace the structure. The district will move forward with the repair project. Mr. Massetti explained the process for waterproofing noting that we received an estimate of 8.5-9 million and will carry a large contingency (3 million, approximately 33%). The replacement project would have cost approximately 80-90 million. There is a possibility of some state funding which we are looking into. The board has approved the hiring of an architect.

Mr. Massetti explained the process for paying for the project noting that a previously planned assessment project will potentially need to be deferred in order to pay for the SMASH/Muir project. Mr. Massetti also noted that it is possible that one or more of the assessment projects could be delayed in DSA at which point the decision would be made for us. If not then we will need to revisit which project to defer.
