3:15 Welcome and approve minutes from 10/15/2020

3:20 School Announcements /Principal's Report - Mr. Miller

**Old Business:**

3:30: Distance Learning Update - Alex & Bella & Teachers (goal 1)  
Alex and Bella shared how distance learning has been for them as the year has progressed and some of the main things that stood out to them. Ms. Smith asked "are you learning?". Mr. Miller then discussed some data done through Ms. Stowell's class. Ms. Stowell discussed distance learning overall and some of the main things she has observed. Mr. Miller discussed the polls taken last Thursday. Mr. Ryan discussed the need for feedback from students. Ms. Smith added to that discussion. Mr. Kertesz discussed how distance learning is for him in comparison with other schools. A conversation followed around generalities of distance learning. Ms. Smith and Ms. Stowell discussed their points of view and added concluding remarks.

**3:50: Formal Adoption of the SPSA**

Mr. Miller discussed the summary of the feedback from the WASC visit, SPSA and SLT goals, strategies and actions to meet goals, needs assessment, adjustments to address distance learning, and the barriers and challenges to progress towards the goals. 4:10: Re-opening Discussion
