# Malibu Unification Negotiations Committee Meeting Minutes

I. Call to Order / Roll Call

The Committee and Superintendent also talked through the possibility that the Board might exercise the option outlined in the Resolution (that established the Committee) that "changes to the negotiated agreement are required, based on comments from the public and its own discussion." If this happens, then the Board may ask the Committee to reopen the negotiations with the goal of incorporating changes articulated by the Board.

Based on an identified shared interest in a clear outcome from the Board's April 20<sup>th</sup>
meeting, the Superintendent agreed to look into scheduling a Brown Act compliant
meeting among selected Committee and Board representatives before the full Board
meeting on April 20<sup>th</sup>.
